# Union County Utilities Authority April 15, 2015 Regular Meeting

Chairman Eastman called the meeting to order at 6:35 p.m., in the meeting room of the Union County Utilities Authority, 1499 Routes 1 & 9 North, Rahway, New Jersey.

Notice of Compliance with the Open Public Meetings Act was read by Joseph C. Bodek, Clerk of the Authority.

A roll call of the Commissioners showed the following present: Chairman Eastman, Vice-Chairman Erdos, Treasurer People, Commissioners Badri, Kahn, Kulish, and Scutari. Also present were alternate Commissioners Bonanno and Lombardo. Commissioner Jackus arrived at 6:37 pm.

Commissioners Absent: Secretary Kennedy.

Others Present: Daniel Sullivan and Tom Brennan of the Authority's staff; Kraig Dowd of Weber Dowd Law; Ed Trainia of CME; Johnathan Williams of DeCotiis, Fitzpatrick & Cole; Deputy Clerk Lisa DaSilva and Clerk Joseph C. Bodek.

Chairman Eastman appointed Alternate Commissioner Bonanno to act for Commissioner Kennedy.

Chairman Eastman led the Pledge of Allegiance.

Mr. Sullivan introduced new Commissioner Laura Scutari who was appointed by the Freeholders to replace Commissioner Huff.

Mr. Bodek provided Proof of Notice of the meeting.

#### Communications

There were no communications.

#### Approval of Minutes

Commissioner Kulish moved for the approval of the public and executive sessions minutes of the meetings of March 18, 2015. The motion was seconded by Commissioner Bonanno and was ordered approved by a roll call vote, with all voting yes, except Commissioners Badri, Kulish, Scutari and Chairman Eastman who abstained.

#### Report of Officers

There were no reports from the officers.

Report of Committees, Staff & Counsel - Public Session I

Finance and Budget Committee.

Commissioner Kulish reported on the meeting of the Finance and Budget Committee. The Committee met and recommended approval of resolution approving the payment of bills and increasing the cap for Lerch, Vinci & Higgins, LLP. Commissioner Kahn moved the resolutions: 1) Approving operating and resource recovery facility vouchers for processing and payment; and 2) Approving consulting and legal vouchers for processing and payment. The motion was seconded by Commissioner Badri and was unanimously ordered approved by a roll call vote.

Commissioner Kulish moved the resolution increasing the cap for Lerch, Vinci & Higgins, LLP in their existing professional services contract. The motion was seconded by Commissioner Badri and was unanimously ordered approved by a roll call vote.

Personnel, Procurement and Insurance Committee

Mr. Sullivan explained there was a slight change to the professional services contract with Arcadis U.S., Inc., and noted it. Commissioner Kulish moved the resolution amending the professional services contract between the Authority and Arcadis U.S., Inc. The motion was seconded by Commissioner Badri and was unanimously ordered approved by a roll call vote.

#### **New Business**

Mr. Bodek spoke about the resolution honoring Commissioner Huff. Commissioner Erdos moved the resolution commending the dedicated public service of Commissioner James D. Huff. The motion was seconded by Commissioner Kahn and unanimously ordered approved by a roll call vote.

Report of Committees, Staff & Counsel - Executive Session

Commissioner Erdos moved to return to public session. The motion was seconded by Commissioner Badri, and was unanimously ordered approved by a roll call vote. The Authority reconvened into public session at 7:28 pm.

Report of Committees Staff & Counsel - Public Session II.

Commissioner Badri moved the resolution authorizing payment to Covanta Union, Inc. of the undisputed amount of the shortfall payment for 2014 pursuant to the amended and restated waste disposal agreement for the operation of the Union County Resource Recovery Facility. The motion was seconded by Commissioner Erdos and was unanimously ordered approved by a roll call vote.
