RESOLUTION OF THE UNION COUNTY UTILITIES AUTHORITY ADJUSTING THE ANNUAL SALARIES OF CERTAIN AUTHORITY STAFF

WHEREAS, the County of Union, New Jersey (the "County") has developed the Union County District Solid Waste Management Plan (the "Plan") in accordance with the New Jersey Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq. (the "Act"), for the purpose of managing the disposal and/or recycling of solid waste generated or disposed of in the County; and

WHEREAS, the County Board of Chosen Freeholder has designated the Union County Utilities Authority (the "Authority"), in accordance with the Act, as the implementing agency for the Plan; and

WHEREAS, the Authority is authorized by the Municipal and County Utilities Authorities Law, N.J.S.A. 40:14B-1, et seq., to appoint and employ, in pertinent part, a secretary executive director, managerial personnel, technical advisors and experts, professional employees and such other employees as it may determine necessary for its effective operations, and in pertinent part, to determine their qualifications, duties and compensations; and

WHEREAS, in carrying out its role, it is in the Authority's best interest to retain experienced personnel to develop and implement an effective and comprehensive solid waste enforcement program, to coordinate the enforcement program with the other operational programs at the County and the Authority and to maintain the efficient operation of the Union County Resource Recovery Facility; and

WHEREAS, the Authority has in its employ certain employees who have and continue to perform their respective duties in a diligent and effective manner; and

WHEREAS, after consultation with the Authority's General Counsel, the Executive Director, and the Personnel, Procurement & Insurance Committee recommend that the Authority recognizes the employees listed herein below for their efforts and services to the Authority.

NOW THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Union County Utilities Authority as follows:

- 1) The above recitals are incorporated herein as if fully set forth at length.
- 2) The Board hereby increases by two percent (2%), per annum, the salary of the following employees:
