NOTICE TO ALL UNION COUNTY MUNICIPALITIES, SOLID WASTE COLLECTORS & HAULERS, MATERIALS RECOVERY FACILITIES (MRF) AND OTHER SOLID WASTE FACILITIES REGARDING <u>TIPPING FEES</u> FOR SOLID WASTE DISPOSAL OF TYPES 13, 13C, 23 AND 27 GENERATED IN THE COUNTY OF UNION AND DISPOSED OF AT THE CANADIAN PACIFIC RAILWAY (CPR) FACILITY LOCATED IN NEWARK, NJ.

Pursuant to the New Jersey Department of Environmental Protection's (NJDEP) Certification of the Union County District Solid Waste Management Plan, all Solid Waste Types 13, 13C, 23 and 27 generated within the County of Union, whether collected by a Union County municipality itself (i.e., municipal DPW), or on behalf of such municipality by contract with a solid waste collector, or whether collected by private solid waste collectors (via contracts or otherwise), from residential generators, governmental generators and /or industrial generators within the County, *must be delivered* to the Canadian Pacific Railway (CPR) Transload facility located within the Oak Island rail yard at *91A Bay Avenue*, Newark, New Jersey 07105.

Please be advised that effective, January 1, 2012, CPR is entitled to a \$1.95 per ton increment in the tipping fee under its contract with the Union County Utilities Authority (UCUA). As a result, effective January 1, 2012 the aggregate disposal fee will be \$95.85 per ton for all Solid Waste Types 13, 13C, 23 and 27 generated within the County of Union and delivered at Newark, CPR facility. The NJDEP certification of the Union County District Solid Waste Management Plan authorizes the Union County Utilities Authority (UCUA) as the implementing agency responsible for enforcing waste flow within Union County.
