RESOLUTION OF THE UNION COUNTY UTILITIES ATHORITY DESIGNATING THE OFFICIAL NEWSPAPER FOR THE AUTHORITY AS THE UNION COUNTY LOCAL SOURCE AND AUTHORIZING THE USE OF THE HOME NEWS TRIBUNE, THE STAR LEDGER and LaVoz AS SUPPLEMENTAL NEWSPAPERS

WHEREAS, the County of Union, New Jersey developed the Union County District Solid Waste Management Plan in accordance with the New Jersey Solid Waste Management Act for the purpose of managing the disposal and/or recycling of solid waste generated in Union County; and

WHEREAS, the Union County Board of Chosen Freeholders has designated the Union County Utilities Authority (the "Authority"), in accordance with the Solid Waste Management Act, as the implementing agency for its Solid Waste Management Plan; and

WHEREAS, the Authority desires to comply with Chapter 231, P.L. 1975, otherwise designated as the "Open Public Meetings Act", N.J.S.A. 10:4-6 et seq.; and

WHEREAS, the Open Public Meetings Act, and more particularly N.J.S.A. 10:4-8.d, requires the Authority to designate at least two newspapers that have the greatest likelihood of informing the public within the Union County Solid Waste Management District of the Authority's public meetings and of other official matters and legal publications of the Authority, and requires the Authority to designate one such newspaper as the "official newspaper" for the Authority.

**NOW, THEREFORE, BE IT RESOLVED,** by the Union County Utilities Authority, as follows:

- 1. The Authority hereby designates *Union County Local Source (Worrall Publications)*, *The Home News Tribune*, *The Star Ledger* and *LaVoz* to receive notices required under the Open Public Meetings Act along with other official or legal advertisements as deemed appropriate by the Authority.
- 2. The Authority hereby designates *Union County Local Source (Worrall Publications)* as the official newspaper for the Authority as required by N.J.S.A. 10:4-8(d).
