**RESOLUTION OF THE UNION COUNTY UTILITIES AUTHORITY  
RECOMMENDING AN ADMINISTRATIVE ACTION PLAN AMENDMENT TO  
THE UNION COUNTY DISTRICT SOLID WASTE MANAGEMENT PLAN TO  
INCLUDE DESIGNATED TRUCK ROUTES FOR ACCESS TO AND EGRESS  
FROM THE UNION COUNTY RESOURCE RECOVERY FACILITY IN  
RAHWAY, NEW JERSEY**

**WHEREAS**, pursuant to the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq. (the "SWMA"), each county within the State of New Jersey is designated a solid waste management district with responsibility for the development of a solid waste management plan setting forth the solid waste disposal strategy to be applied in the district; and

**WHEREAS**, the Union County District Solid Waste Management Plan (the "County Plan"), developed in accordance with the SWMA, was initially adopted by the Union County Board of Chosen Freeholders ("Freeholders") on June 7, 1979 and certified by the New Jersey Department of Environmental Protection ("NJDEP") on August 13, 1980, and has since been amended from time to time; and

**WHEREAS**, the Union County Utilities Authority (the "UCUA") is a public body corporate and politic of the State of New Jersey, created by the Freeholders, in accordance with the provisions of the Municipal and County Utilities Authorities Law, N.J.S.A. 40:14B-1 et seq., by an Ordinance adopted on June 5, 1986, as amended on December 11, 1986, and exercises essential governmental functions for the public health, benefit and welfare of the citizens of the County; and

**WHEREAS**, the Freeholders have designated the UCUA as the implementing agency for the County Plan charged with implementing and recommending updates and amendments to the aforesaid County Plan from time to time and selected to plan, acquire, construct, maintain and operate facilities for the processing and disposal of County solid waste and/or the recovery of recyclable materials; and

**WHEREAS**, UCUA, in its capacity as implementing agency for the County Plan, has previously developed, implemented and financed a solid waste management system that includes the construction of the Union County Resource Recovery Facility ("UCRRF") to provide for the processing and disposal of all municipal solid waste generated within the geographic boundaries of the County; and

**WHEREAS**, UCUA is the owner of the UCRRF, a 1,540 tons per day waste-to-energy facility, located in the City of Rahway, New Jersey, which has been leased to and is operated by Covanta Union, LLC. ("Covanta"), formerly known as Ogden Martin Systems of Union, Inc., as part of a restructuring undertaken by the Authority in 1998 following the decision in Atlantic Coast Demolition and Recycling, Inc. v. Board of Chosen Freeholders of Atlantic County et al., 112 F.3d 652 (3d Cir. 1997), cert. den. 522 U.S. 966 (1997), pursuant to the terms of a Facility Lease Agreement, dated as of July 15, 1998 (the "Facility Lease"), an Amended and Restated Waste Disposal Agreement, dated as of February 15, 1998, most recently revised in 2016 as the "Third Amendment To Amended And Restated Waste Disposal Agreement" and "Second Amendment To Facility Lease Agreement"; and

**WHEREAS**, NJDEP solid waste regulations, specifically N.J.A.C. 7:26-3.4 (j), require all solid waste vehicles used for transportation of solid waste to access and exit solid waste facilities in accordance with designated solid waste vehicle routes as specified in either the appropriate district solid waste management plan or the permit for the particular solid waste facility; and

**WHEREAS,** NJDEP initially approved ingress and egress truck routes for vehicles disposing of Union County generated solid waste at the UCRRF by certification dated January 18, 1989, which was subsequently amended and certified on March 22, 1990 and May 18, 1994; and

**WHEREAS,** Covanta Union, LLC and UCUA desire to modify the trucks routes to and from the UCRRF in the County Plan in accordance with the procedures set forth in the SWMA and its implementing regulations to reflect the realignment of Routes 1&9; and

**WHEREAS,** the truck routes to the UCRRF proposed for incorporation in the County Plan are similar to routes that have been posted at the UCRRF and utilized by solid waste haulers since the realignment of Routes 1&9 and, therefore, present no new traffic or environmental issues for consideration; and

**WHEREAS,** NJDEP solid waste regulations pertaining to amendments of a county solid waste management plan (N.J.A.C. 7:26-6.11(b)2) specifically provide that the designation of, or change to, prior approved truck routes to and from solid waste facilities may be accomplished by administrative action by the implementing agency as an alternative to a full plan amendment requiring notice and a public hearing before the governing body of the county; and

**WHEREAS,** UCUA has determined that the inclusion of the truck routes to and from the UCRRF does not warrant a formal plan amendment process as set forth in N.J.A.C. 7:26-6.11; and

**WHEREAS,** the approval of an amendment to the County Plan by administrative action to include the proposed truck routes to and from the UCRRF is in the best interests of the County and its citizens, and is necessary for the continued efficient operation of UCUA;

**NOW, THEREFORE, BE IT RESOLVED,** by the Commissioners of the Union County Utilities Authority as follows:

**Section 1.** The aforesaid recitals are hereby incorporated by reference, as if set forth at length herein.

**Section 2.** An amendment to the County Plan, by administrative action, to incorporate the proposed truck routes to and from the UCRRF as shown on the attached exhibits is hereby authorized.

**Section 3.** The Executive Director and Special Counsel are hereby authorized and directed to submit the proposed truck routes to and from the UCRRF and a copy of this Resolution to NJDEP as an administrative action in order to obtain such approvals as may be necessary under law.

**Section 4.** A copy of this Resolution, together with copies of the proposed truck routes to and from the UCRRF, shall be forwarded to the Clerk of the County for public inspection, and this Resolution shall also available, upon execution by the parties, for public inspection at the offices of the Authority at 1499 Routes 1 & 9 North, Rahway, New Jersey.

**Section 5.** This Resolution shall take effect immediately.
