**RESOLUTION OF THE UNION COUNTY UTILITIES AUTHORITY
AUTHORIZING THE USE OF AUTHORITY PROPERTY IN WATERFRONT PARK
BY THE RAHWAY RIVER WATERSHED ASSOCIATION**

WHEREAS, the Union County Utilities Authority (“Authority”) is the owner of real property in and around Waterfront Park in Union County, New Jersey, adjacent to the Rahway River (“Authority Property”); and

WHEREAS, Rahway River Watershed Association, Inc. (“RRWA”), a nonprofit organization, is organizing a kayak trip down the Rahway River on Saturday, June 4, 2022, and has requested permission to use the Authority Property on that date for the purpose of parking their vehicles and launching their kayaks from Waterfront Park into the Rahway River; and

WHEREAS, the Authority has considered the request by RRWA, subject to certain conditions set forth herein below.

NOW THEREFORE BE IT RESOLVED, by the Union County Utilities Authority as follows.

1. The aforesaid recitals are incorporated herein as though fully set forth at length.
2. The Authority hereby grants the RRWA permission to use the Authority Property on Saturday, June 4, 2022, for the purpose of parking vehicles and launching kayaks from Waterfront Park into the Rahway River, subject to the execution of an appropriate hold harmless and indemnification agreement, as well as the RRWA’s provision to the UCUA of a certificate of insurance evidencing coverages of type(s) and amount(s) acceptable to the Authority.
3. This Resolution shall take effect immediately.
