

**RESOLUTION OF THE UNION COUNTY UTILITIES AUTHORITY
AWARDING A CONTRACT FOR PAINTING SERVICES**

WHEREAS, in order to carry out the stated purposes and goals for which the Union County Utilities Authority (“Authority”) was created, as well as the powers granted by the Municipal and County Utilities Authorities Law, N.J.S.A. 40:14B-1 et seq., and pursuant to N.J.S.A. 40A:11-1 et seq., the Authority has determined that it is in need of painting services for portions of the Authority’s administrative offices (the “Services”); and

WHEREAS, the Authority solicited and received quotations from multiple vendors through the issuance of a Request for Quotations for the Services; and

WHEREAS, after considering all relevant factors, the Authority’s staff has advised that the proposal received from 3 R Painting, LLC (“3 R Painting”) is the most advantageous proposal that meets the specific needs and requirements of the Authority.

NOW, THEREFORE, BE IT RESOLVED, by the Union County Utilities Authority as follows.

1. The aforesaid recitals are incorporated herein as though fully set forth at length.
2. The Authority hereby authorizes an agreement with 3 R Painting LLC, 122 Drummond Ave., Neptune, New Jersey 07753, for the provision of painting services, as described in and subject to the terms set forth in the Authority’s Request for Quotations and in 3 R Painting’s proposal, at a total cost not to exceed \$3,000.00.
3. The Authority hereby authorizes and directs the Authority’s Executive Director to take all appropriate actions to effectuate the subject purchases with 3 R Painting under the terms set forth above.
4. This Resolution shall take effect immediately.
