RESOLUTION OF THE UNION COUNTY UTILITIES AUTHORITY ADOPTING POLICIES GOVERNING EMERGENCY ACTION & FIRE PREVENTION, PERSONAL PROTECTIVE EQUIPMENT, HAZARDOUS SUBSTANCES, AND BLOODBORNE PATHOGENS

WHEREAS, pursuant to the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq., each county within the State of New Jersey is designated a solid waste management district with responsibility for the development of a solid waste management plan setting forth the solid waste disposal strategy to be applied in the district; and

WHEREAS, the Board of County Commissioners (formerly "Board of Chosen Freeholders") of the County of Union (the "County") has adopted the Union County District Solid Waste Management Plan, as amended from time to time (the "County Plan"); and

WHEREAS, the County has designated the Union County Utilities Authority (the "Authority") as the agency responsible for implementing the County Plan; and

WHEREAS, the Authority has a duty to provide a safe and healthy work environment for all of its employees, and to implement policies and procedures to help prevent and mitigate potential hazards, as well as and enable efficient and informed responses to emergency situations; and

WHEREAS, the Authority wishes to adopt formal policies governing emergency action & fire prevention, personal protective equipment, hazardous substances, and bloodborne pathogens.

NOW, THEREFORE, BE IT RESOLVED, by the Union County Utilities Authority, that the policies listed below are hereby adopted in substantially the same forms as attached hereto.

- 1. Emergency Action & Fire Prevention Plan;
- 2. Personal Protective Equipment Program;
- 3. Hazard Communication Plan; and
- 4. Bloodborne Pathogens.

BE IT FURTHER RESOLVED that the Executive Director shall ensure that the provisions of the above policies are promptly issued to the Authority's employees, and implemented and enforced in a manner consistent with directives contained within the policy documents.

BE IT FURTHER RESOLVED that this Resolution shall take effect immediately.
