RESOLUTION OF THE UNION COUNTY UTILITIES AUTHORITY DESIGNATING NEW AUTHORIZED SIGNATORIES FOR THE AUTHORITY'S ACCOUNTS WITH CROWN BANK AND HAVEN SAVINGS BANK.

WHEREAS, in order to maximize the interest rates earned by its funds deposited and/or invested pursuant to its cash management plan, the Authority has adopted Resolution No. 54-2023 to authorize the deposit, investment, and/or transfer of funds with and among the financial institutions designated under the aforementioned cash management plan; and

WHEREAS, in furtherance of Resolution No. 54-2023 and the aforementioned cash management plan, the Authority wishes to designate new authorized signatories for certain bank accounts it has with Crown Bank and Haven Savings Bank, and to authorize certain actions as deemed necessary in connection therewith as set forth herein below.
