**RESOLUTION OF THE UNION COUNTY UTILITIES AUTHORITY  
AUTHORIZING REJECTION OF ALL BIDS FOR NON-PROCESSIBLE  
WASTE DISPOSAL SERVICES AND AUTHORIZING RE-BID**

**WHEREAS**, pursuant to N.J.S.A. 40A:11-1 et seq., the Union County Utilities Authority (the "UCUA") advertised for and received bids for Non-Processible Waste Disposal Services; and

**WHEREAS**, the Authority received bids from Interstate Waste Services, Inc. and Waste Management of New Jersey, Inc.; and

**WHEREAS**, the UCUA seeks to revise the specifications, including: revising the anticipated tonnage per year quantity, among other things; and

**WHEREAS**, pursuant to N.J.S.A. 40A:11-13.2(d), the UCUA may reject all bids when the UCUA wants to substantially revise the specifications for the goods or services; and

**WHEREAS**, the UCUA has determined it is necessary to reject all bids pursuant to N.J.S.A. 40A:11-13.2(d).

**NOW, THEREFORE BE IT RESOLVED**, by the Union County Utilities Authority as follows:

**Section 1.** The aforesaid recitals are hereby incorporated by reference, as if set forth at length herein.

**Section 2.** The UCUA hereby rejects all bids submitted for Non-Processible Waste Disposal Services as the UCUA has determined it necessary to substantially revise the specifications for Non-Processible Waste Disposal Services.

**Section 3.** The UCUA is hereby authorized to revise the specifications and readvertise and accept bids for Non-Processible Waste Disposal Services in accordance with the Local Public Contracts Law.

**Section 4.** A copy of this Resolution shall be made available for public inspection at the UCUA's administrative offices located at 1499 Routes 1 & 9 North, Rahway, New Jersey.

**Section 5.** This Resolution shall take effect immediately.
